

## **TEAM RECTOR'S INTRODUCTION**

The Annual Report is an opportunity to reflect on the very many activities which make up the life of this church community, and to give our thanks to all of you who make the life, mission and ministry of this parish possible. Here on the Manor, we are one parish with three distinctive buildings, one of which is leased to the Manor Church and Community Project, and prayed in and supported by people who are serving the church and wider community with generosity of heart and spirit. We are committed to building stronger relationships with our Mission Area and particularly with our 'next-door neighbours' at St Leonards, as well as with our ecumenical partners locally.

#### 5. Meeting of Parishioners - Election of Church Wardens

Sue Williams is currently the only Churchwarden for Manor Parish and no additional nominations had been received. We are grateful to Sue for all her continued hard work and dedication to the Parish and for agreeing to continue for one final year, after which she will step down. She has also continued as the only Parish Verger for the last 7 years, which has proved demanding of her time and starting to affect her health. Consequently, she will be stepping down from this post and asked that more help be forthcoming from parishioners in future. The Annual Report had been collated and published by Sue since 2008 and she felt it long overdue to retire from this too, and hand this task over to someone new.

#### 6. Presentation of Annual Report and Accounts for 2022

In her presentation, Revd Batten expressed thanks to Sue Williams for collating and producing the Annual Report and Accounts, as she will be handing this task on next year. The report was comprehensive in its coverage of the great variety of work undertaken in the parish, and Revd Batten was delighted that it looked forward in so many ways. She expressed sincere gratitude for everyone's involvement in so many aspects of church life, especially behind the scenes and welcomed the diversity and inclusivity shown in the planning of future growth in the parish. She went on to highlight plans for our churches to become Eco Churches, to increase our digital presence, have greater appeal to young

people, to continue work on our Mission Action Plan and make improvements in the fabric of our buildings.

#### **Money and Finance**

Chris Digman presented his Treasurer's Report, summarising the key financial information:

2022 saw a surplus of £4459 recorded in our accounts for the Parish after carrying forward income appropriately into 2022 for wages. The surplus should have been £2619 however as the final payment towards the Common Fund came out just after the end of 2022. Overall our small surplus should be seen in the context that the Parish was in deficit of £4039 for 2021.

Although giving was down and we were still unable to hold Summer or Winter Fairs, Hall Lettings were double that of 2021. Contactless Giving via a card reader at St Aidan's was introduced with the plan of developing more digital and online giving in future.

Chris reminded us that there are still major maintenance issues to be faced and very urgent decisions to be made and that we may have a financial deficit next year, as so much major work needs doing urgently.

Thanks were expressed to Chris Digman for producing such an informative and comprehensive set of accounts.

It was proposed that this Meeting accept the Annual Report and Accounts as presented: **Proposed: Martin Lawton** Seconded: Catherine Fish All in favour with no abstentions.

## 7. Election of Attercliffe Deanery Synod representatives

Revd Batten explained the importance of the Synodical governance in the CofE, and how relevant it was to the parish. At grass roots level, we can make a difference by having the parish represented at Deanery Synod, as we then had the option of bringing PCC resolutions for discussion at Deanery Synod, and they could then be presented to Diocesan Synod for consideration to progress to General Synod. So we can, and should, make our voices heard in order to bring about change in the CofE.

The following nomination had been correctly received prior to the start of the meeting:

#### 8. Election of Lay Members to the PCC

Jenny Richardson was now an ex-officio member in her role as Deanery Synod Rep and resignations had been received from: Adele Nicholls-Lee, Alison Digman (in 2021), Eizabeth Dziruni, Catherine Fish who all received personal gifts of thanks from Revd Batten.

The following members continued their term on PCC for another year: Sioned-Mair Richards Julie Child-Cavill As this now left a possible 7 vacancies and no applications for membership had been received, the Meeting was pleased to receive the acceptance from **Stephen Ramshaw** to be Co-opted to the PCC for the forthcoming year.

#### Proposed: Julie Child-Cavill Seconded: Sioned-Mair Richards

It was agreed that the new PCC needs to grow in number, as there were essential roles to fill particularly, PCC Secretary, Parish Safeguarding Officer and Electoral Roll Officer.

Thanks were given to all who had served on the PCC during 2022.

David Ryder from St Mark's Broomhill & Broomhall, had accepted the invitation to take on the role, with the approval of this Meeting.

## **TEAM RECTOR'S REPORT**

If 2022 was a year of change, 2023 has been a year of growing – slowly – and consolidating, of responding to the long-term effects of the pandemic on members of our congregation and organisations around us, of discerning what to take up, and what to lay down or postpone to a later date.

If in 2022 we took many more funerals than baptisms, in 2023 we had many more baptisms than funerals, and celebrated a wedding and renewal of wedding vows, too. We were delighted when one of our young people decided that he was ready for confirmation, and we rejoiced with him and his family at this wonderful celebration at Sheffield Cathedral. Each of these occasions was an utter privilege and a time of being alongside people at a significant moment, whether sad or joyful, often forging lasting relationships.

It was also a year of exploring how we as a church community can connect better with our local services, organisations and activities, and what we can offer to enhance wellbeing. We want people to experience church in a way that's invitational and inclusive. Based on an estate, we are church in the public square and embedded in our local community, yet for many church is unknown territory. We want to make the first step over the church door threshold easier for them. There are moments of challenge and disappointment when the fabric of an ageing building is letting us down, alongside delight when a new support group for parents of disabled children takes off, with families of all shapes and sizes filling the centre to capacity and children loving the great play facilities on offer. The ups and downs of church life remind us to pay attention to God at work in and through us, to hold on to the glimpses of joy and live lives shaped by gratitude.

#### So let me share some of the highlights of 2023:

- After a year without dedicated Safeguarding Officer, Moni Ifayomi offered her services along with her expertise as a Nurse Tutor, and we are so pleased that she has taken on this role;
- A successful grant application to the Sheffield Church Burgesses Trust for the post of Support & Development Worker for which we are most grateful;
- Witnessing to our faith takes many forms: a prayer walk with local people during Lent led to the now well-established monthly 'Manor Parish Litter Pick', a time to prayerfully look after our area, often followed by sharing home-made cake and a natter once the litter has been bagged up;
- Our Children's Leaders were inspired by the 'Joined Up' conference for Christian Youth Leaders across the region, while our young people had a great time at 'Breathe Deep' at the cathedral which has become a firm favourite in the annual calendar;
- This year we offered 'Ashes to Go' outside St Aidan's on Ash Wednesday which led to deep conversations, carried a cross to the city centre on Good Friday as a form of public witness, and offered to pray with people around the cross who asked for prayer;
- At the annual Chrism Mass at the Cathedral one of our young people was chosen to read and represent lay people in the diocese, and we were very proud of him.
- As we opted to return to sharing the chalice, we authorised four new Eucharistic Ministers, a diverse and faithful group of people committed to building up God's Church;

- We are supporting a member of the congregation who is a student on the Foundation Programme at St Peter's College;
- Music which draws on different traditions: beautiful organ music and thoughtful hymn choices offered by our Worship Leader Catherine Fish; drumming and singing workshops for all generations; the We Who Worship group who are introducing us to new worship songs; joint celebrations with the Zimbabwean Shona community and African drumming; a visit by the Steel City Choristers, whose glorious singing nearly raised the roof and generated much interest among our children and their families in traditional choral singing, and so much more ...;
- Making links with Whirlow Grange Spirituality Centre and encouraging members of the congregation to make use of this peaceful space for retreats and time for reflection;
- Paying attention to contemplation and activism, offering church space for personal and communal prayers for justice and peace;
- Hosting of the Amos Trust Christmas Tour, a Places of Peace Christmas Event for Gaza with 120 people sharing food and listening to poetry and stories, with guests from Palestine;
- We registered as an Eco Church and are keen to make progress in 2024.

#### There have also been challenges:

- Responding to the problems typical of ageing buildings with obsolete heating systems;
- Addressing anti-social behaviour around St Swithun's during the summer months;
- Exploring ways of keeping our young people involved and interested as they grow older;
- Seeking to respond to the growth of poverty and social pressures within the parish which has been exacerbated by the continued rise in the cost of living;
- Reaching out to the individuals and families who have moved into the new-builds on the estate, many of whom are from abroad and have few local connections;
- Trying to increase the number of volunteers at church when most people are already very busy with work and family commitments, or have poor health
- Trying to Increase giving to church when many in the congregation are struggling financially.

#### *Outreach/Wider Community*

The Manor Parish has a long history of being very much part of its local community, and this is something to build on as our area is changing with its new housing developments, people from a wide range of backgrounds moving into the area, and local organisations and services are responding to the growing demands of the neighbourhood.

Over the last year we have continued to host the busy S2 Foodbank, and are glad that clients receive support with debts and now also have access to the new Food Shop across the road from St Swithun's.

Our relationships with the local primary schools remain strong, with regular visits to our buildings and assemblies; I am also governor of two of the schools. We join in with the 186<sup>th</sup> Scout Group whenever possible, and were glad to mark Remembrance Sunday with a parade with scouts and the Seventh Day Adventists' Pathfinder Group joining us – the excellent drumming could be heard across the estate! I have regular meetings with the local GP representative to explore areas for collaboration and support, and was delighted to be able

to offer a 'home' to the Forget-Me-Nots, a dementia-friendly community choir needing a practice space. We are also in regular conversation with our local councillors and can help make connections between different parts of the community.

As parish priest for all the parish I have taken a large number of funerals, and bereavement support is important to us; in 2023 we facilitated a group which was particularly appreciated by young(er) people who had experienced loss, and attended the Baby Loss Service at Whirlow Grange together. Our annual Memorial Service was much appreciated, and gave space to adults and a large group of children to grieve and find comfort. While this brief 'run-through' of our community engagement can only provide a snapshot, this year's Christingle was a noteworthy event, as it was hosted by us and supported by a choir from the Ethiopian Pentecostal community. It was a beautiful, international and inclusive service, with oranges sponsored by one of our local Funeral Directors, and a lovely way to see in Advent.



#### Spirituality and Worship

Spirituality and worship, outreach and the wider community, mission, ministry and evangelism are all interwoven here in the Manor Parish. Our Sunday worship is always a Eucharist and as we have now returned to the Common Cup, we have commissioned four new Eucharistic Ministers. We are delighted that this group includes both the young and the more mature in years, a snapshot of our congregation.

The children stay with the adults for the first part of the service, and then leave for Sunday Club, and return for the Eucharist. We all now follow the lectionary, with the children's leaders using the Roots programme and integrating Godly Play into their sessions.

Welcome, music and worship leading, children's work, leading intercessions and preaching, the tech desk, setting up for services and taking care of the linen, providing refreshments and washing up – all of this is such a team effort, and we are grateful for all of you who take on tasks 'front of house' or behind the scenes.

On Wednesday nights we meet on zoom for Night Prayer, which is hosted by a small team and provides a quiet space which is sometimes joined by members of the congregation who temporarily live abroad. Together we pray, reflect on the day, are community to each other. Occasional offices are important to us: we seek to be alongside people in their grief and joys, and help them mark the transitions in life. In 2023 I conducted 6 funerals, one wedding and one renewal of wedding vows, baptised 15 children and one adult, and celebrated one thanksgiving for the safe delivery of a baby. Being allowed to be alongside people at such times is an utter privilege which I shall never take for granted.



The flow of the liturgical year runs through parish ministry: a Lent Group exploring Acts run jointly with St Mark's Broomhill, a group for those exploring faith using material from 'Leading Your Church into Growth' facilitated by us for the wider mission area and hosted by ecumenical partners, baptism and confirmation preparation sessions, a retreat offered by the diocesan Lights for Christ worker, regular preaching by our Church Army representative, individual visits to the diocesan spirituality centre arranged for members of the parish – all these are the building blocks laying the foundations for closer cooperation with the Mission Area and other faith communities in Sheffield S2.

#### Outlook for 2024

- After a successful day workshop on 'Shaping your Church' offered to the congregation and wider community in January 2024 which started the Vision and Mission Action Planning we need to continue the process and agree priorities for the parish;
- Following agreement to appoint a Centenary Worker to engage with our families and young people we need to work with the diocese on funding and recruitment;
- Continuing to work through our maintenance plan to ensure our buildings are in good order and fit for purpose paying particular attention to St Aidan's water ingress, heating system and floor;
- Deepening our relationship with our Mission Area and ecumenical partners;
- Registered as an Eco-Church, we need to commence preparations for the bronze status assessment;
- Continue to provide spaces where we can explore spirituality and faith, prayer and scripture, and develop a sense of belonging and service to our church family and wider community.

I am writing this report with a sad and grateful heart. In January 2024 I announced that due to life changes which I hadn't anticipated, I would be leaving the parish and Sheffield at the end of April to move with my partner to her new post in North Yorkshire. My overriding sense at the moment is gratitude for all that has been. I feel truly blessed to be your Rector and part of the community on the Manor, and I thank God for each and every one of you. May we face the changes which lie ahead of us with grace and lovingkindness.

## FABRIC AND MAINTENANCE

The Churchwarden's role is really without boundaries despite being neatly bundled into Management, Maintenance and Mission (3Ms), and is only achievable through the wonderful support of our congregation, staff, PCC and those User Groups who hire our premises. Safeguarding is deemed to be everyone's business and, in my mind, so are the 3Ms. Without helpful comments pointing out maintenance needs; health and safety hazards; attending various meetings and workshops, and willing help from volunteers, our churches would not function. So it is with my thanks to everyone who makes our churches work.

Maintenance of church buildings is essential in ensuring that our lovely church buildings continue to be welcoming and safe places for people to come. It is also key to taking the first steps in reducing carbon emissions and saving energy. The Diocesan Buildings Team, together with the Giving & Generosity team provide much-needed advice and resources to assist churchwardens and parishes, providing a variety of useful and informative workshops, and I have made full use of these excellent people and resources.

Sadly, our finances don't allow us to keep up with so many of the problematic maintenance issues that appear on our ever-growing 'Things To Do' list. I am grateful to our Parish Support and Development Worker, Nicola Smith and Treasurer, Chris Digman, for keeping a watchful eye on how much we can afford to spend and, together with our Rector, Sibylle Batten, we are prioritising the issues as funding allows.

Our architect, Tom Crooks provided an outline report on possible improvements and refurbishment at St Swithun's, but our planning was overtaken during the summer holidays by anti-social behaviour around the site. Stones thrown at cars; minor arson; groups of children and young people (young teens) vandalising the area around the church, all very intimidating with impact on the foodbank and shop. PCSOs/police were involved and CCTV in operation. Eventually, the situation did improve once the children returned to school.

St Aidan's was badly affected by summer storms damaging the roof, with loose slates on the spire slipping and causing major water ingress in the hall resulting in more damage to the wooden block flooring, and an almost permanent collection of assorted containers collecting rainwater. The storms also broke some of the guttering and caused more water to flood the accessible toilet, which has been rendered unsafe and unusable since then.



After 24 years the inefficient, and now obsolete, heating system at St Aidan's finally gave up the ghost at the height of winter and is in urgent need of replacing. As our Energy Footprint Tool shows our carbon emissions are unacceptably high, I am delighted that we are now signed up to working towards the Bronze Eco Award, so this will impact on the type of system we need and can afford.

Meetings have been held with the architect and contractors regarding the way forward in dealing with the roof damage, acquiring a new heating system, replacing the Accessible toilet, as well as replacing the outdated and obsolete fire and intruder alarm systems at both churches. In order to access the roof space at St Aidan's, we also need to plan and install a safe access system usable by all contractors.

I am grateful to Revd Sibylle Batten in her tireless pursuit of seeking the appropriate sources of funding for so much of the work needed, and hope that 2024 will see major improvements to our beautiful church buildings. I would love to produce a much happier and positive report next year!

How grateful I have been for the support and kindness of so many people in our parish. I had planned on not standing as Churchwarden for another year, as I'd only agreed to support the parish through the Vacancy of 2020-21 and continue to support our new Rector during their first year. Age and health issues added to my decision to leave but, since the news of Sibylle's planned departure in April 2024, I have agreed to support the parish through another Vacancy which we all hope will not be long and protracted. Bless you all and thank you for continuing to make my job bearable, rewarding and worthwhile! It has been an honour to serve the parish and community for another year.

#### PCC REPORT FOR 2023

During the year we welcomed Stephen Ramshaw to full membership following his co-option and in June, we welcomed the cooption of Martin Lawton to the PCC.

The Parish was entitled to have **9** elected members of the laity on the PCC, due to the fact there were **91** members on the Electoral Roll and during 2023 the following people served on the PCC:

## **TREASURER'S SUMMARY FOR THE YEAR 2023**

This year saw a deficit of £1145 recorded in our accounts for the Parish. This is in comparison to 2022 where the Parish had a surplus of £4459. The final payment (£1841) of the 2022 Common Fund was made in early January 2023 along with £352 of Diocesan Fees, totalling £2193. Our Common Fund pledge for 2023, was £22087, whereas our 2023 contribution was £19896, a short fall of £2191 (very close to the 2022 payments that were made). Without the 2022 payments, we would have been at a similar deficit level and made our 2023 Common Fund commitment.

Our accounts show funds as unrestricted, unrestricted designated and restricted. This means:

- Restricted funds are those that have been given for a specific purpose
- Unrestricted are not for any particular purpose and can be spent as deemed fit.

• Unrestricted designated have been set aside for specific purpose, in our case typically for works for the building and fabric.

#### Income

We are extremely grateful for congregational giving. Overall, giving was up compared with 2022 in all areas (Gift Aid giving, Envelope, Sunday Eucharist and Individual Donations). Considering the struggle and pressures the cost-of-living crisis has placed on families, we have been blessed by the Parish's continued generosity. This formed 45% of our total unrestricted income. It's worth noting that our individual donations are high. This is primarily due to giving from individuals in the Parish that cannot be gift aided (as they typically have effectively been gift aided through their work).

Our hall lettings were higher than those received in 2022 which has been particularly helpful with a near £8000 increase. Our letting income continues to be boosted by payments from the food bank based at St Swithun's Church which is a critical service to the local community. We did not hold church fayres again this year which represents circa £2000 of income not coming in.

Grants were significant in 2023 in particular for the high energy bills. A total £5300 was received.

In 2022 we installed contactless giving facilities to enable those attending and visiting the church to more easily give. This yielded a small return and will take time to embed this practice. We hope this alternative giving method can create an uplift in giving during services and in particular at celebratory one-off services such as Baptisms and Weddings.

#### Expenditure

As noted in the opening of the summary, we paid close to 11 out of 12 months of the Common Fund to the Diocese in 2023 and made up the shortfall in 2022.

Our utility costs were greater than in 2022 as buildings become more utilised and we started to see the increase in costs as a result of higher gas and electricity prices. The combined bills for 2023 were around £18700, an increase of about £10000 compared with 2022 bills. A significantly higher water bill was paid in 2023 compared with 2022, due to an internal plumbing problem in the men's toilets at St Swithun's.

Maintenance and repairs expenditure was typically similar to years prior to 2022. Work here included addressing health and safety issues. Our other costs remained similar to 2022.

We continue to witness prudence and hard effort by many in the Parish to keep our expenditure as low as possible.

#### Financial support to the Parish

The Sheffield Burgesses Church Trust are good friends to us, and we are very grateful for their generosity. The Manor Parish was one of the eight parishes with an allocation of £9,375 of additional funding from the Burgesses which was paid directly the Diocese. We

also received from them the funding for our Support and Development Worker again who is essential in helping to run the Parish.

Our Support and Development Worker will continue to support the PCC and Rector in exploring other grant funding and income generating opportunities to make us financially more resilient whilst making the church environment more welcoming and therefore more 'mission-friendly'.

The Burgesses also contributed to the ecumenical funding mix reflected in the partnership which is the Manor Church and Community Project (MCCP) and which pays for the Community and Cohesion Worker. But besides their significant financial contribution our Link Burgess also offers a listening ear and takes the role of a much-appreciated 'critical friend'.

#### 2024

Looking forward, we recognise that each year provides its own financial difficulties. The shift in utility prices down for gas and electricity is very welcome. We will continue to keep a close eye on the finances and be prudent in our expenditure. We will continue to rely in part on the generous giving of the Parish and maintaining similar levels of income from letting. In addition, the Parish team continues to work hard to obtain grants which we apply for (often we do not receive notification for until later in the year).

Finally, I would like to thank all those who manage the parish finances across the churches, limit expenditure and maximise income. In particular Nicola Smith (Support and Development Work), Sue Williams (Church Warden) and Sibylle Batten (Rector). Thanks also to David Ryder who was our Independent Examiner and provided helpful advice on improving our practice.

## ATTERCLIFFE DEANERY SYNOD

2023 has been a year of change in our deanery: we said good-bye to our Area Dean, Fr Philip Knowles who retired from this post, and in early 2024 we welcomed Revd Lucy Sablan and Revd Sue Steward, our new Co-Area Deans.

2023 also saw many clergy appointments in the deanery, all vacancies were filled, and this brought renewed energy and focus to Deanery Synod meetings. We value the opportunity to represent the parish in these meetings and are committed to ensuring that the voices of estates parishes such as ours are heard within the diocese and beyond. In our meetings throughout the year we were exploring how we could better share resources across mission areas and the deanery, support each other in governance, and suggesting workshops on topics including building regulations, church growth and youth work, the work of St Peter's College, and how to create a more inviting online presence for parishes.

In October Bishop Pete and senior staff spent a day in the deanery. Accompanied by members of the Manor Parish, they prayer walked the area and heard first-hand about the joys and challenges of life on the estate, and the important role churches play in communities such as ours where life can be tough for many people. The day included conversations with clergy and PCC members about the future strategy of the diocese, links with the national church and funding opportunities. We were encouraged to dream, to use our imagination – what do we need to flourish as community? As a deanery we took this challenge on board and are continuing the conversation with lively and engaged discussions at our synod meetings and 'getting to know each other' sessions which will stand us in good stead moving forward.

## SAFEGUARDING

Revd Sibylle Batten



Manor Parish continues to follow the recommendations and guidelines set out in the Diocesan Safeguarding Policy. There have been no incidents reported in the year ending December 2023. After nearly a year without designated Parish Safeguarding Officer (PSO), with the Team Rector and Churchwarden taking the safeguarding lead, we are delighted that Moni Ifayomi has offered her services and considerable expertise in the field through her

work as a Nursing Tutor, and we are thankful to the Diocesan Safeguarding Team for their support in inducting her into her new role.

We have reviewed and updated our Parish Safeguarding Policy. We also reviewed the training and DBS requirements for church personnel/volunteers. DBS checking is a slow and onerous process. We have compiled our own records showing DBS and training status. The

latter is necessary to ensure that people have done training as we have no ability to access CofE records. So this relies on people feeding back to the PSO or Team Rector and providing copies of their training certificates. We rely greatly on people doing their training promptly and giving feedback. If volunteers are unable to access or complete online application forms or training material, we facilitate access for them.

All documentation is stored correctly by the parish in accordance with current legislation. Safeguarding continues to be a standard item on the agenda of each PCC meeting. All PCC members have been encouraged to register to receive the Diocesan Safeguarding newsletter as this is a valuable source of information and it clearly explains a range of current issues and points of interest within the Church of England. All training within the Diocese can be accessed directly from the newsletter. The Parish Safeguarding Team: Moni Ifayomi, PSO, Sue Williams, Churchwarden and Revd Sibylle Batten, Team Rector, are available for people to contact if they have any questions or concerns. Happily, we have not had to pass on any safeguarding concerns to the DSA in the past year nor have we had to raise any concerns with the PCC. Manor Parish will continue to adapt and review all relevant policies and risk assessments thus ensuring that we do everything possible to safeguard all members of our church community.

## **CHILDREN'S AND YOUTH WORK**

Sunday Club and Ark continued throughout 2023 led by Claire Dalpra, Andrew Wooding, Vickie Woodley, Julie Child-Cavill, Lilian Tootell (when she can help) and Malcolm Simmons (before his health complications).

At the start of the year, the 2023 Breathe Deep diocesan youth day took place in Sheffield cathedral. Thanks to Andrew for organising, Nicola for booking the tickets, and Julie and Sibylle helping to supervise the eight young people attending.

In the Spring, Rachael, Emma and Sibylle attended a local conference for all-age worship and Emma, Sibylle and Claire attended the Joined-Up conference (the diocesan day for children's and youth leaders). For Mothering Sunday, we made clay angels to give to out to our congregation. Sibylle also arranged for a drumming worship at St Aidan's.

On Good Friday, we organised the outdoor gathering on Manor Fields with games, a short Good Friday reflective service and picnic lunch. We had 30 in all, and were blessed with good weather again. After Easter, we welcomed children from Pipworth school on their annual visit to St Swithun's.

Attendance is extremely variable with between 2-8 children in Sunday Club and between 15 and 30 people at Ark. Therefore, over the summer - led by Sibylle - we reviewed our existing work. After much discussion, we decided to keep Ark as it is but arrange the chairs in a semicircle, which feels more welcoming. In Sunday Club, we made the decision to return to using Roots material which follows the lectionary more closely than our previous monthly themes. In September, we waved goodbye to three of our older teenagers who were leaving home for university and blessed them (and everyone else) for a new start to the school year. In October, we invited everyone to stay after Ark for a harvest lunch.

In November, Emma Okpalaeke organised a well-attended Remembrance Day service with the Cubs and Scouts. Later in the month, one of our young people got confirmed at the cathedral.

In December, we held our fourth Christmas Toddler Disco. Organised by Julie, we welcomed between 30 and 40 families from the community into our building for the disco. Ruth Mills was the DJ, Sunday Club leaders and volunteers organised hot dogs and drinks, and Santa turned up in person for a grotto, with his elves giving out a wrapped present for every child.

This year's Christingle was well-attended with 70 oranges, generously donated by Simpson's Funeral Directors. A few of us joined together for the Crib Service at St Swithun's on Christmas Eve.

## MANOR PARISH, GAZA AND THE HOLY LAND

Manor Parish has already signed "Cry for Hope", a call for action to the worldwide, ecumenical church from Palestinian Christians. They say, "We make this call out of concern for the future of both peoples. ... our call is rooted in the logic of love that seeks to liberate both the oppressor and oppressed in order to create a new society for all the people of the land."

The weekly parish newsletter often contains updates about the Holy Land, and intercessions for those there have been a regular feature in the church. Church members, alongside other Christians, have supported vigils and protests in the city centre.

The situation in Palestine, and particularly Gaza, became more extreme from October. In December, the parish with Kairos Sheffield hosted "Places of peace, a Christmas event for Gaza", part of an Amos Trust tour. This was planned in the summer, but the escalation of violence in Gaza drew a larger number of people. Members of the congregation were very supportive, welcoming and catering for around 120 people from a variety of denominations and places. The event included the Sheffield Tadhamon choir, part of Sheffield's Coalition campaigning for Sheffield to become an Israeli apartheid free zone.

#### Financial Statements for the Year Ended 31st December 2023

Report of the Independent Examiner to the members/trustees of the Ecumenical Parish of Sheffield Manor Parochial Church Council.

I report on the financial statements of the Parochial Church Council of the Ecumenical Parish of Sheffield Manor ("the charity") for the year ended 31st December 2023 which are set out on pages 2 to 6.

#### Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year (under section 144(2) of the Charities Act 2011 (the 2011 Act)) and that an independent examination is needed.

It is my responsibility to:
